

# Privacy Statement

### 1. INTRODUCTION

This Privacy Statement describes how LEONARDO FILM collects, uses, and shares information about you. By using my website or interacting with LEONARDO FILM in any other way, you consent to the collection, use, and sharing of information as described in this Privacy Statement.

### 2. COLLECTION OF INFORMATION

LEONARDO FILM may collect personal information about you, such as your name, email address, postal address, phone number, or other information that can be used to identify you. This information may be collected when you:

- 2.1 Contact LEONARDO FILM, for example to ask a question or make a request;
- 2.2 Make a purchase from an online store owned or operated by LEONARDO FILM.

I may also collect information about your use of my website, such as the pages you visit and the links you click. This information may be collected using cookies or similar common methods of collecting usage data.

### 3. HOW YOUR INFORMATION IS USED

LEONARDO FILM may use your information for the following purposes:

- 3.1 To provide products and services to you;
- 3.2 To communicate with you about products and services;
- 3.3 To respond to your inquiries and provide customer support;
- 3.4 To personalize your experience on this website;
- 3.5 To analyze and improve products, services, and promotional materials;
- 3.6 To prevent fraud and protect the security of this website and its users.

### 4. INFORMATION SHARING

LEONARDO FILM may share your information with third parties in the following circumstances:

- 4.1 With service providers who perform services on behalf of LEONARDO FILM, such as website hosting, data analysis, and email marketing;
- 4.2 With selected business partners, such as distributors or advertising agencies, to promote products and services;
- 4.3 With law enforcement or government authorities when required to by law or to protect LEONARDO FILM's legal rights;

LEONARDO FILM may also share aggregated or de-identified information that cannot be used to identify you with third parties.

## 5. YOUR CHOICES

You may opt out of receiving marketing communications from LEONARDO FILM at any time by contacting me directly. See statement 9.

You may also disable cookies in your web browser, although this may limit your ability to use certain features of this website.

Under European GDPR users of this website have the following data protection rights:

- The right to access – Users have the right to request copies of their personal data. Fees may apply.
- The right to rectification – Users have the right to request that any collected information they believe is inaccurate be corrected. Users also have the right to request that any information they believe is incomplete be completed.
- The right to erasure – Users have the right to request for their personal data to be erased, under certain conditions.
- The right to restrict processing – Users have the right to request for the processing of their personal data to be restricted, under certain conditions.
- The right to object to processing – Users have the right to object to the processing of their personal data, under certain conditions.
- The right to data portability – Users have the right to request that their data be transferred to another organization, or directly to them, under certain conditions.
